AMENDED INTERAGENCY AGREEMENT

This Amended Interagency Agreement is entered into by and between the **Puget Sound Clean Air Agency**, (hereinafter referred to as the "Agency"), a municipal corporation of the laws of the State of Washington, and **City of Tacoma**, acting through its **Environmental Services Department**, (hereinafter referred to as the "ESD"), 326 East D Street, Tacoma, WA 98421.

WHEREAS, the Board of Directors of the Puget Sound Clean Air Agency deems it desirable to amend the original Agreement, No. 2013001-0-IAA, dated November 15, 2012, for the services of ESD to perform burn ban observations for the Agency; and

WHEREAS, ESD represents and warrants that it is available, experienced, and qualified to perform said amended services; and

NOW, THEREFORE, the Agency and ESD mutually agree to amend the original Agreement as follows:

- 1. Section 1.A.6. The last sentence of Section 1.A.6. is amended to read as follows: "In accordance with Section 2, "Compensation," the Agency shall reimburse ESD up to \$55,000 in Agency Fiscal Year 2013 for performing any and all duties described in Section 1(A) above, and Section 1(B) and Attachment A below."
- 2. Section 2.B. The first sentence of Section 2.B. is amended to read as follows: "The total amount paid by the Agency for performance of the work under this Agreement shall not exceed \$55,000."
- 3. Any future changes to Attachment A may be accomplished by mutual agreement of the parties through a letter or e-mail communications.
- 4. All other terms and conditions of Agreement No. 2013001-0-IAA remain in full force and effect.
