

NOTICE OF PUBLIC COMMENT PERIOD
PUGET SOUND CLEAN AIR AGENCY
Proposed Order of Approval No. 11265

We are giving public notice that Targa Sound Terminal has filed an application with the Puget Sound Clean Air Agency (the Agency) to terminal (receive, store & ship) up to 151,500,000 gallons per year of natural gasoline, a liquid that comes from natural gas wells and is often blended into motor vehicle gasoline. Targa is already permitted to terminal gasoline, isooctane, Bakken crude oil, and denatured ethanol. The project includes the modification of four existing tanks to enable storage of these products. Gasoline is received by pipeline and the other products by railcar. The permit to terminal natural gasoline would allow an annual average of one unit train per week (107 railcars) to be offloaded from railcars and loaded onto marine vessels.

The emissions associated with this project could total up to 24 tons per year of Volatile Organic Compounds, including 2.8 tons per year of Hazardous Air Pollutants, 1.3 ton/yr of Toxic Air Pollutants, and 186 pounds per year of benzene.

PRELIMINARY DETERMINATION

The Agency has completed a review of application No. 11265 and has made a preliminary determination that the proposal meets all the requirements of Regulations I, II and III and should be approved. Review of the environmental impacts of terminaling such products at the facility's rated capacity was previously conducted by the City of Tacoma and the city has determined that there is no need for additional review.

PUBLIC COMMENT

The application and the information considered in making this preliminary determination are on file and available for inspection at the Agency's office located at 1904 3rd Ave, Suite 105, Seattle, Washington, telephone (206) 689-4011. The proposed Order No. 11265 is also available at the Agency's website www.pscleanair.org. Written comments will be accepted until the end of the 30-day public comment period per WAC 173-400-171. All comments received during the comment period will become part of the public record. The applicant, any interested governmental entity, any group, or any person may request a public hearing within the thirty-day public comment period. A request must indicate the interest of the entity filing it and why a hearing is warranted. The Agency may hold a public hearing if it determines that significant public interest exists. Once the Agency has reviewed and

responded to comments from the public, the draft Order will, if necessary, be revised, and then issued in final form.
