## MEMORANDUM OF AGREEMENT

---

This amended Memorandum of Agreement ("MOA") is entered into between the **Puget Sound Clean Air Agency**, (hereinafter referred to as the "Agency"), a municipal corporation of the laws of the State of Washington, and **King County**, (hereinafter referred to as the "County"), 201 S. Jackson, Suite 701, Seattle, WA 98104.

**WHEREAS**, the Board of Directors of the Agency deems it desirable to amend the original MOA 2021-020-0 dated March 10, 2021 with the County for the purposes of updating emission inventories for the Puget Sound region; and

**WHEREAS**, the parties enter into this amended Agreement based on the understanding of the parties set forth below;

**NOW, THEREFORE**, the Agency and the County mutually agree as follows:

A. The Section 1.C., Project Milestones and Deliverables, of MOA No. 2021-020-0 is replaced as follows:

"The Agency and the County mutually agree to the project milestones and their respective due dates as follows:

<b>Project Milestones</b>	<b>Due Date</b> (milestones may be provided in advance of due date)
<b>The Agency</b> will approve the geographic emission inventory scope and methodology for all four counties	June 30, 2021
<b>The County</b> will submit to the Agency all the raw data collected by the consultant to date for the geographic inventories	September 30, 2021
<b>The County</b> will submit to the Agency a draft report of the geography-based inventory for King County	September 30, 2021
<b>The County</b> will submit to the Agency all remaining raw data and working files for the geographic-based inventories for all four counties, including graphs, data spreadsheets, calculations, and assumptions	November 30, 2021
<b>The County</b> will submit to the Agency a draft report of geography-based inventories for Kitsap, Snohomish, and Pierce	November 30, 2021

counties (combined with or separate from the King County inventory)	
<b>The Agency</b> will review the draft reports and provide technical feedback to the County	10 business days after submission of drafts
<b>The County</b> will submit to the Agency the final report of geography-based inventories for King, Kitsap, Snohomish, and Pierce counties. This will include a summary of all four counties, and all raw data, working files, and calculations.	January 31, 2022

The Due Date of any of the above Project Milestones may be changed to a later date at the sole discretion of the Agency's Project Manager. Any change in Due Date must be communicated in an email from the Agency's Project Manager to the County's Project Manager."

B. All other terms and conditions of original MOA No. 2021-020-0 remain in full force and effect.
