The Puget Sound Clean Air Agency (the Agency) is publishing a public notice for a Notice of Construction Order of Approval for Fluid Motion, LLC in Arlington and is also publishing a preliminary Determination of Nonsignificance as Lead Agency for the State Environmental Policy Act (SEPA) associated with this Notice of Construction Order of Approval. Fluid Motion is an existing Title V Air Operating Permit source which fabricates fiberglass boats. The proposed Order would expand operations to a third building (Building 10). The boats fabricated in Building 10 would range from 25-28 feet and are manually fabricated with open molds. Gel coat resin, vinylester and polyester resins are applied to the molds to produce hulls, decks, and small parts. Upholstery and wood fixtures are also assembled at the facility.

The emissions associated with this project were evaluated and could total up to 9.9 tons/year styrene, 0.7 tons/year of methyl methacrylate and 11.4 tons/year of volatile organic compound (VOC). The 11.4 tons/year total VOC includes the styrene and methyl methacrylate emissions listed. Each of the chemicals contributing to the total of 11.4 tons/year VOC are also classified as Toxic Air Contaminants (TACs).

### PRELIMINARY DETERMINATION

The Agency has completed a review of application No. 12411 and has made a preliminary determination that the proposal meets all the requirements of Regulations I, II and III and should be approved, subject to the conditions in the draft Order of Approval.

The Agency, as the lead agency for this proposal, has made a preliminary determination that the proposal would not have a probable significant adverse impact on the environment for purposes of SEPA. An environmental impact statement (EIS) is not required under RCW 43.21C.030(2)(c). This decision was made after review of a completed Environmental Checklist and other information on file at the Agency. This information is available to the public upon request and is available on the Agency website through this public comment period. A Determination of Nonsignificance (DNS) for this proposal is issued in accordance with WAC 187-11-340(1), WAC 197-11-970, and Puget Sound Clean Air Agency Regulation I, Sections 2.07 and 2.12.

### PUBLIC COMMENT

The public comment period begins on June 25, 2024 and ends on July 25, 2024. The information considered in making this preliminary determination, the draft Order No. 12411, and the Determination of Nonsignificance are available at the Agency's website [www.pscleanair.gov](http://www.pscleanair.gov). All comments received during the comment period will become part of the public record. Once the Agency has reviewed and responded to comments from the public, the proposed Order of Approval will, if necessary, be revised and either denied or issued in final form.
